SUPPLEMENTARY REGULATIONS**

1. The trial is open to all **Adult and Youth Grades**
2. The trial will be over a **number of laps on Private Ground**, each lap having a number of observed sections, and all sections must be attempted in the correct order. These sections will be indicated by Yellow markers at the start and White markers at the Finish of the section. In-between markers will be Red (right) and Blue(left). There will be various lines within these sections depending on the grades
3. **Safety helmets** must be worn as per M.C.U.I (UC) LTD regulations
4. If the rider has the **assistance of a Minder** the minder must complete an entry form and sign in . The minder must wear the same protective clothing as competitor at all times. The minder is not allowed to ride the sections.
5. Riders must follow and stay to the marked course at all times.
6. Photographs may be taken and displayed on the internet or newspaper
7. **NO RIDING IN CARPARK DURING OR AFTER EVENT ANYONE DOING SO WILL BE EXCLUDED FROM THE EVENT.**
8. **Photographs or video's may be taken during the event.**
9. Filling up with petrol, will only be permitted on the marked area provided. Anyone not seen doing so will be excluded from the event.
